Letter to governors and trustees: qualification results 2024

Sir Ian Bauckham CBE, Chief Regulator, Ofqual, Updated 3 October 2024

Dear Governor or Trustee,

I am writing to you as Ofqual's Chief Regulator to outline the national context for qualification results this year. Having served as a senior leader in schools for over 2 decades, I appreciate the significant contribution governors and trustees make to schools and colleges up and down the country. As such I believe it's important for you to have information about the national context as you work with your leadership teams to understand the qualification results for your school, college or trust.

Pupil Premium/Service Pupil Premium, 30th September

<u>The EEF Guide to the Pupil Premium Discussion prompts for governors and</u> <u>trustees to support an effective strategy</u>

As a school governor or trustee, you have an important role to play in supporting and challenging the leadership team at your school to improve outcomes for socio-economically disadvantaged pupils. How the school spends its Pupil Premium funding is an important part of this role.

This table shows how the pupil premium grant is allocated to schools and local authorities in the 2024 to 2025 financial year, based on per pupil rates.

Funding criteria	Amount of funding for each primary-aged pupil per year	Amount of funding for each secondary-aged pupil per year
Pupils who are eligible for free school meals, or have been eligible in the past 6 years	£ 1,480	£ 1,050

Service pupil premium

Service pupil premium is additional funding for schools with pupils who have parents serving in the armed forces.

Pupils in state-funded schools in England attract the service pupil premium grant, at the rate of:

• £340 per eligible pupil in the 2024 to 2025 financial year

Publishing your strategy

You have until 31 December each year to publish your statement. This will enable you to take the needs of your new intake into account. I

If you have developed a multi-year strategy for pupil premium, you must review your strategy and publish an updated statement every year

Pupil attendance in schools,26th September

This release covers the 2024/25 academic year from 09 September to 13 September 2024.

Staffing and employment: advice for schools, 2nd October

Guidance for managing staff and employment issues.

Updated the sections on time off and flexible working, to reflect legislative changes that came into effect in April 2024. See sections 5.4-5.6 & 5.7-5.10 for details.

Extract to note:

In delegating functions, the governing body must not lose sight of the fact that it continues to retain overall accountability for the decisions made by those to whom the function has been delegated. As a result, it is important that local procedures are reviewed regularly by the governing body; for example, satisfying themselves that the staffing functions are being addressed and the right people are fulfilling these roles on its behalf.

School organisation: local-authority-maintained schools

Statutory guidance for proposers and decision makers about opening, closing or making organisation changes to local-authority-maintained schools. Opening, closing and amalgamating schools

School Teachers' Review Body remit letter for 2025,30th September

The Secretary of State's letter to the School Teachers' Review Body asking for recommendations on teachers' pay and conditions for 2025.

The government's intention is to announce the upcoming pay awards as close to the start of the financial year of 1 April as possible.

It is unfortunate that, given the knock-on effects from the delays to the previous round, it is unlikely that the pay award will be announced before maintained schools should be setting their budgets

DfE has commissioned a review of teaching and learning responsibility (TLR) payments

The School Teachers' Review Body (STRB) has been asked for a recommendation on whether changes to the pro rating of TLR payments should be made to enable "greater flexibility".

The school teachers' pay and conditions document (STPCD), which must be followed by maintained schools and is observed by many academies, states that certain TLR payments "must be paid pro rata" for part-time staff.

Cost of school uniforms survey 2023,27th September

This report surveys the cost of school uniform in 2023 and assesses the relative changes to that cost since the previous study. It also provides information on the changes schools are making to their uniform policy in the light of statutory guidance.

<u>Sustainability leadership and climate action plans in education, updated 20th</u> <u>September</u>

The strategy states:

"By 2025, all education settings will have nominated a sustainability lead and put in place a climate action plan". This includes early years settings, schools, multiacademy trusts, colleges, and universities.

Sustainability leadership could be a group of people or an individual responsible for the development and implementation of a climate action plan.

As senior decision makers, SLT and governors should support and drive your sustainable activity. They should:

- provide the authority and support to drive and embed culture change
- ensure climate change and sustainability feature on the agenda at key meetings
- be responsible for succession planning, so that commitment to sustainability endures in the setting

School food: guidance for governors, Updated 19 September 2024

The Department for Education recommends that all governors "work with the senior leadership team to develop a whole school food policy that sets out the

school's approach to its provision of food, food education (including practical cooking), the role of the catering team as part of the wider school team and the school's strategy to increase the take-up of school lunches.

It is the statutory responsibility of the governing body and trustees to ensure the <u>School Food Standards</u> are being met and <u>Ofsted</u> are putting a much greater focus on how schools are creating a culture and ethos of healthy eating.

Ofsted Updates

Inspecting schools: guide for maintained and academy schools,7th October

This guide gives a summary of what schools should expect and what they need to do as part of an Ofsted inspection.

Notice of an inspection

Ofsted will contact the school by telephone to announce a graded or ungraded inspection after 9.30am on a Monday morning.

We may notify schools of an urgent or monitoring inspection on any day. If we have notified a school of an inspection that is subsequently deferred, we can notify that school of the new inspection date on any day of the week. If a school is open in a week that includes a bank holiday, we may notify the school on the Tuesday of that week.

Inspecting schools: guidance for parents,7th October

A leaflet for parents and carers of children whose school is due for inspection.

<u>Selecting new schools and schools that undergo significant change for</u> <u>inspection</u>,7th October

This guidance explains how Ofsted selects new schools for inspection. It also explains how we select for inspection those schools that have undergone significant change, such as the addition of a key stage, phase or the merger with another school.

Until September 2024, graded inspection of schools gave an overall effectiveness grade, in addition to the key judgements and any provision judgements. Overall effectiveness grades given before September 2024 will continue to be visible on school inspection reports and on Ofsted's website. From September 2024, graded inspections will not include an overall effectiveness grade. Schools inspected from then will not have the same way of working out when to expect their next inspection as other schools. We will set out the expected dates for when we will next inspect them from September 2025. These schools should not expect to receive an ungraded or graded inspection before then. Some could receive an urgent or monitoring inspection, which can be deemed a graded inspection.

Academy Updates

ESFA Update

Transfer of ESFA functions into the Department for Education

The Department for Education (DfE) announced the decision to transfer the current functions of the ESFA into the department.

The Education and Skills Funding Agency will be "integrated into the core Department for Education" by March 2025.

The move will happen over two stages and give schools a "single point of contact for financial management and support."

Schools financial support and oversight functions will transfer from October 1 and be brought together with the regions group, nine areas overseen by regional directors.
